## **HOW TO JOIN**

It is imperative that prospective new members read and understand the Standard Operating Procedures as set forth on the Maxey Rifleman Gun Club website. www.maxeygunclub.com

The Club charges an Initiation Fee for new members and memberships that have been expired for more than one month.

Membership in the National Rifle Assn. and the Texas State Rifle Assn. is encouraged but not required. However, we offer a discount for Members of the Armed Forces, Law Enforcement, NRA & TSRA.

## Regular

Dues: \$60.00 annually plus a one-time initiation fee of \$60.00

NRA or TSRA Members

Dues: \$50.00 annually plus a one-time initiation fee of \$50.00

Military & Law Enforcement

Dues: \$35.00 annually plus a one-time initiation fee of \$35.00

For those members who would like to take advantage of a multiyear membership discount, the following rates would apply

3 year membership with a 10% discount	\$162.00
5 year membership with a 25% discount	\$225.00
3 yearmembership for Law Enforcement, NRA, & TSRA.	\$120.00
5 year membership for Law Enforcement, NRA, & TSRA	\$187.50

New members wanting to join for multi years must include the one-time Initiation fee as listed for Annual Membership. (\$60.00 for regular membership, \$50.00 for Law Enforcement, NRA, & TSRA).

3. If you so choose, you may mail the completed forms with payment to Maxey Rifleman Gun Club, P. 0. Box 1091, Paris, TX 75461. After processing, you will receive a confirmation by text or email with your member I.D. and gate code.
